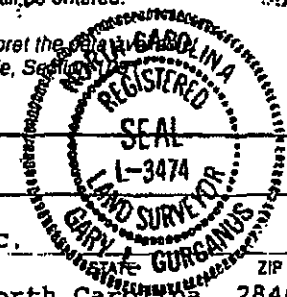

SECTION E CERTIFICATION

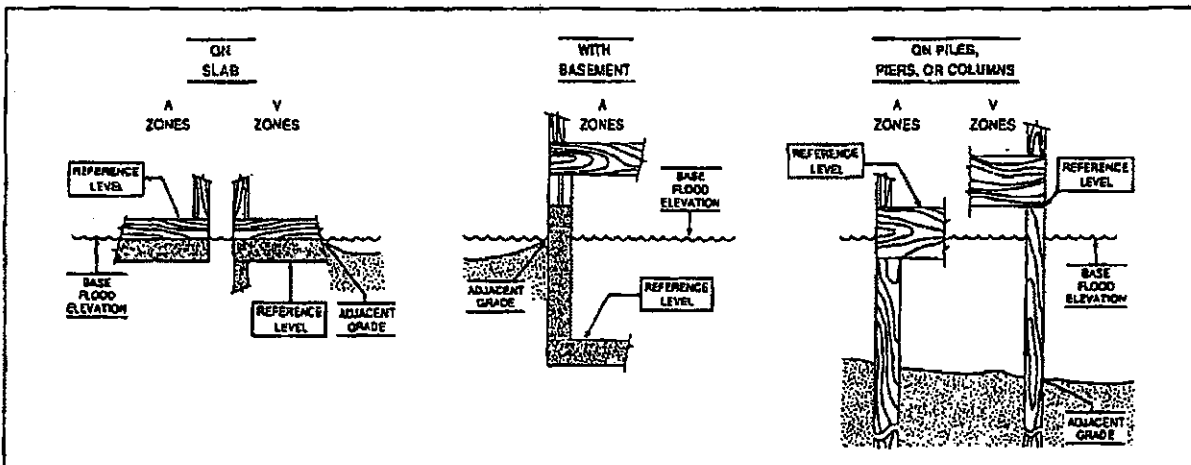

The house appears to be two living levels on pilings with ground level enclosure having finished sheetrock walls and proper openings. The elevation of the elevated finished floor is 19.2 feet.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
