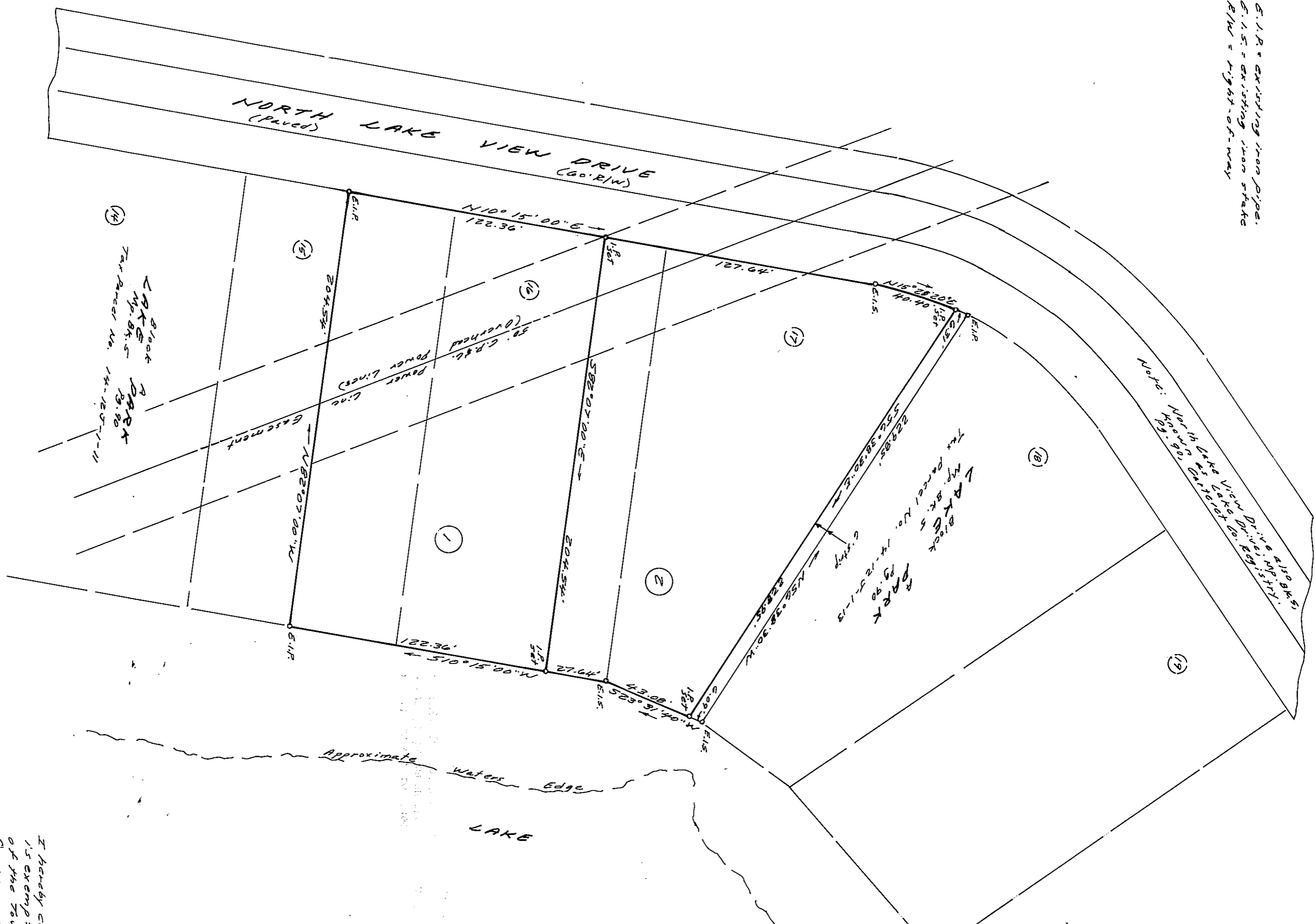
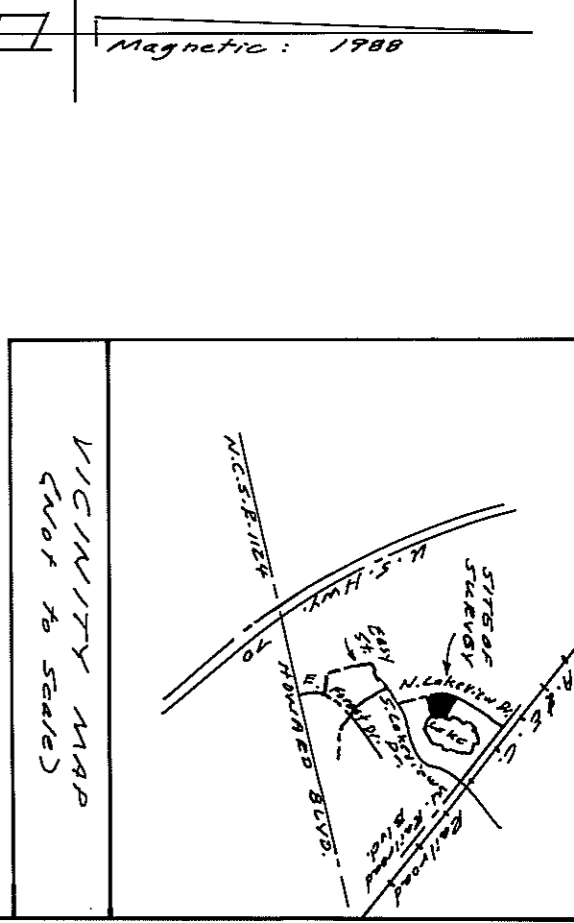


LEGEND: 6" R = existing iron pipes.

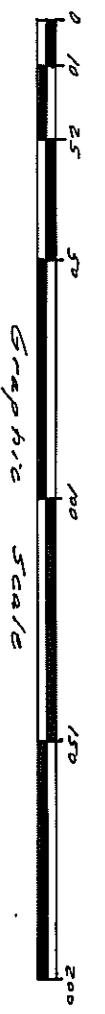
