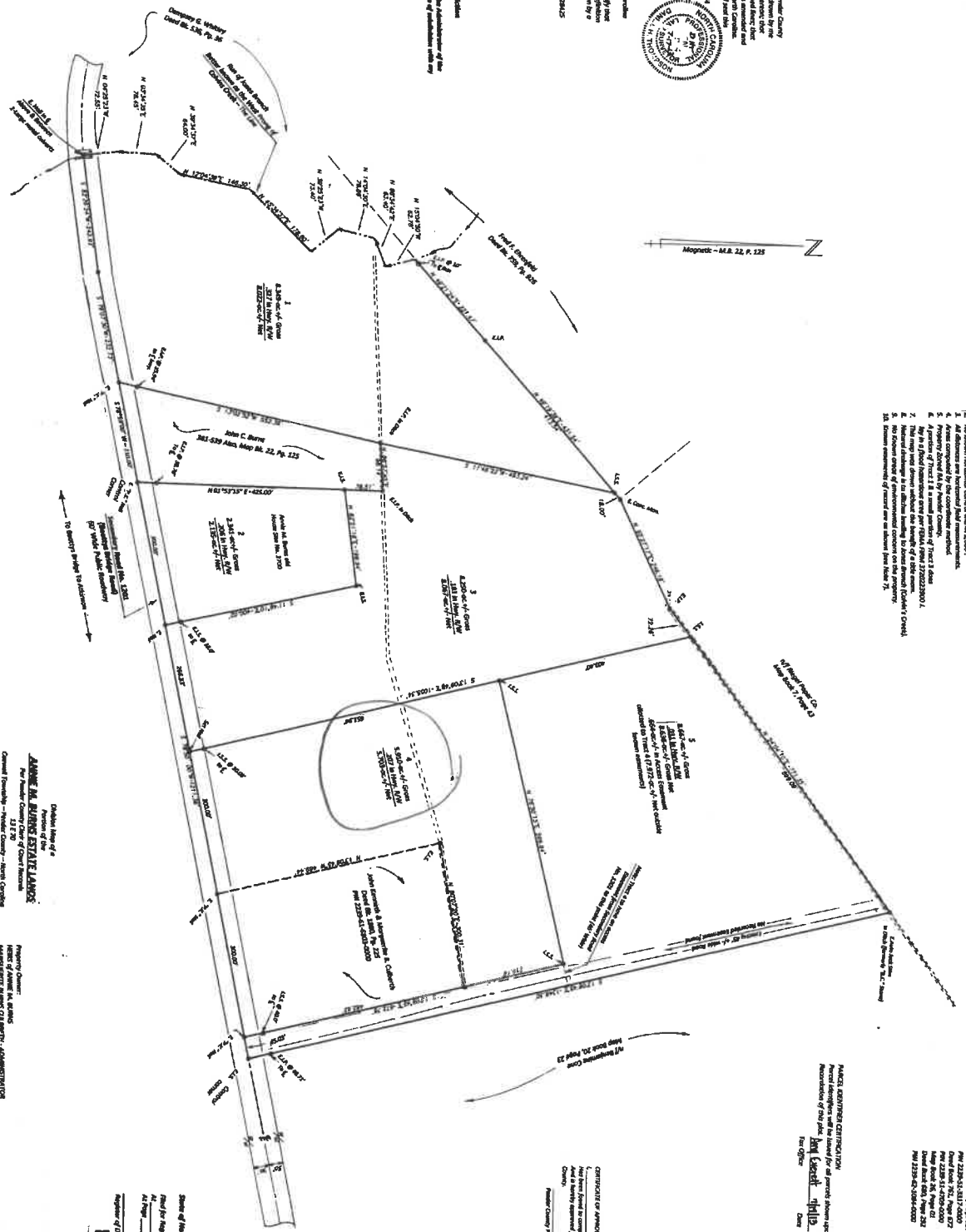


LEGEND

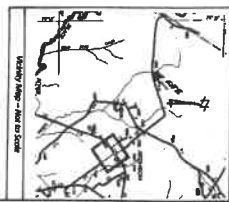
