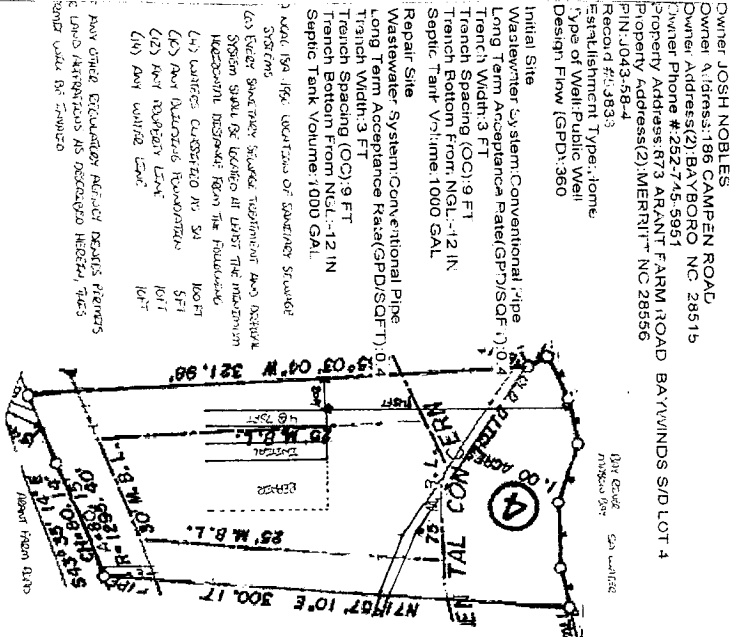

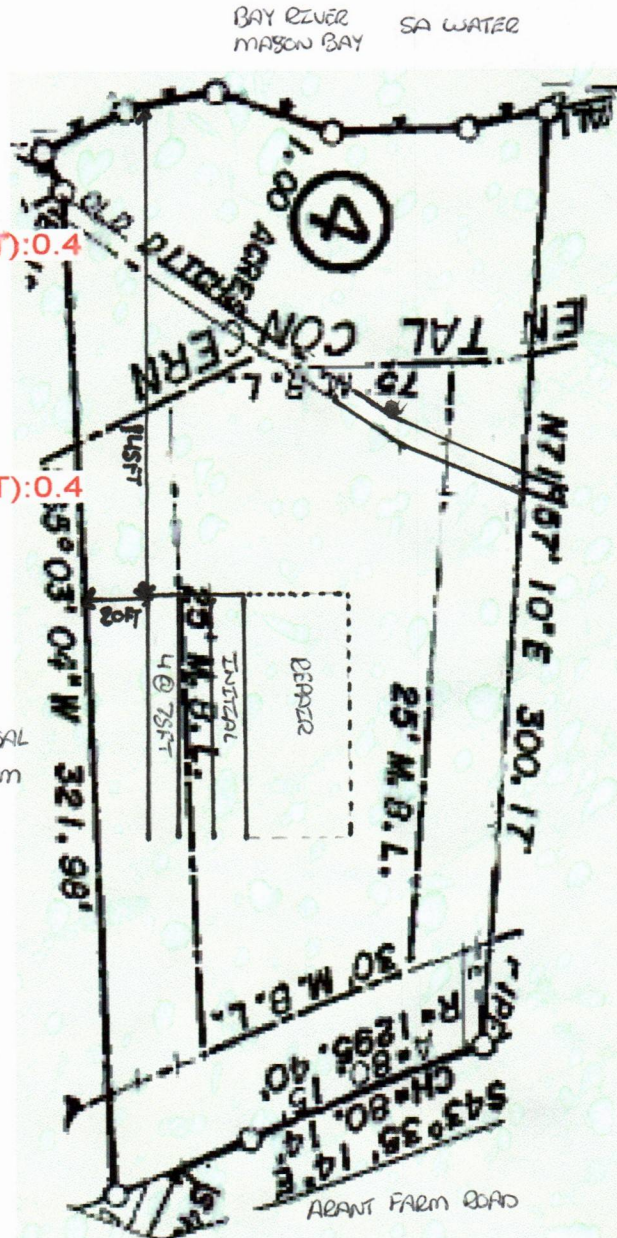

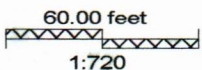

- (1) WATERS CLASSIFIED AS SA 100 FT
- (10) ANY BUILDING FOUNDATION 5 FT
- (12) ANY PROPERTY LINE 10 FT
- (14) ANY WATER LINE 10 FT

IF ANY OTHER REGULATORY AGENCY DENIES PERMITS FOR LAND ALTERATIONS AS DESCRIBED HEREIN, THIS PERMIT WILL BE INVALID.
