WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in the City of Lockwood Folly Township, Brunswick County, North Carolina and more particularly described as follows:

BEGINNING at a point in the southern right of way of U.S. Highway 17, said point of beginning marks a corner with International Paper Company, according to a plat of said Paper Company property recorded in Map Cabinet 3 at Page 146, said point of Beginning also being situate $36^{\circ} 43' 43''$ East 105 feet from a P.K. nail in a 72 inch culvert in Williams Branch; runs thence the following courses and distances along the run of Williams Branch: South $36^{\circ} 43' 43''$ East 125.02 feet; thence South $83^{\circ} 30' 23''$ East 61.53 feet; thence South $41^{\circ} 07' 41''$ East 52.29 feet; thence South $70^{\circ} 26' 17''$ East 60.01 feet; thence South $160^{\circ} 26' 07''$ West 38.90 feet to a new iron pipe in the run of Williams Branch, a northwestern corner with property now or formerly owned by Tom Swain according to a deed recorded in Deed Book 146, at Page 135; thence along the northern line of property now or formerly owned by Tom Swain South $89^{\circ} 44' 09''$ West 697.76 feet to a new iron pipe in the southern right of way of U.S. Highway 17; thence along the southern right of way of U.S. Highway 17 North $66^{\circ} 43' 42''$ East 524.54 feet to the point and place of Beginning, and being all of Parcel C, a 1.65 acre tract of land according to a plat captioned "Survey for Harold I.
