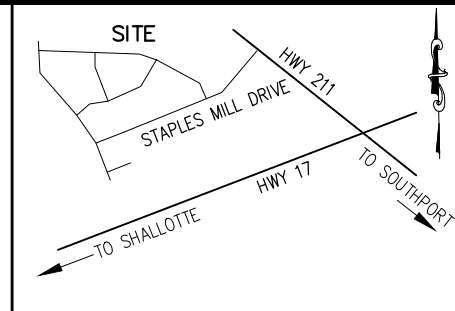

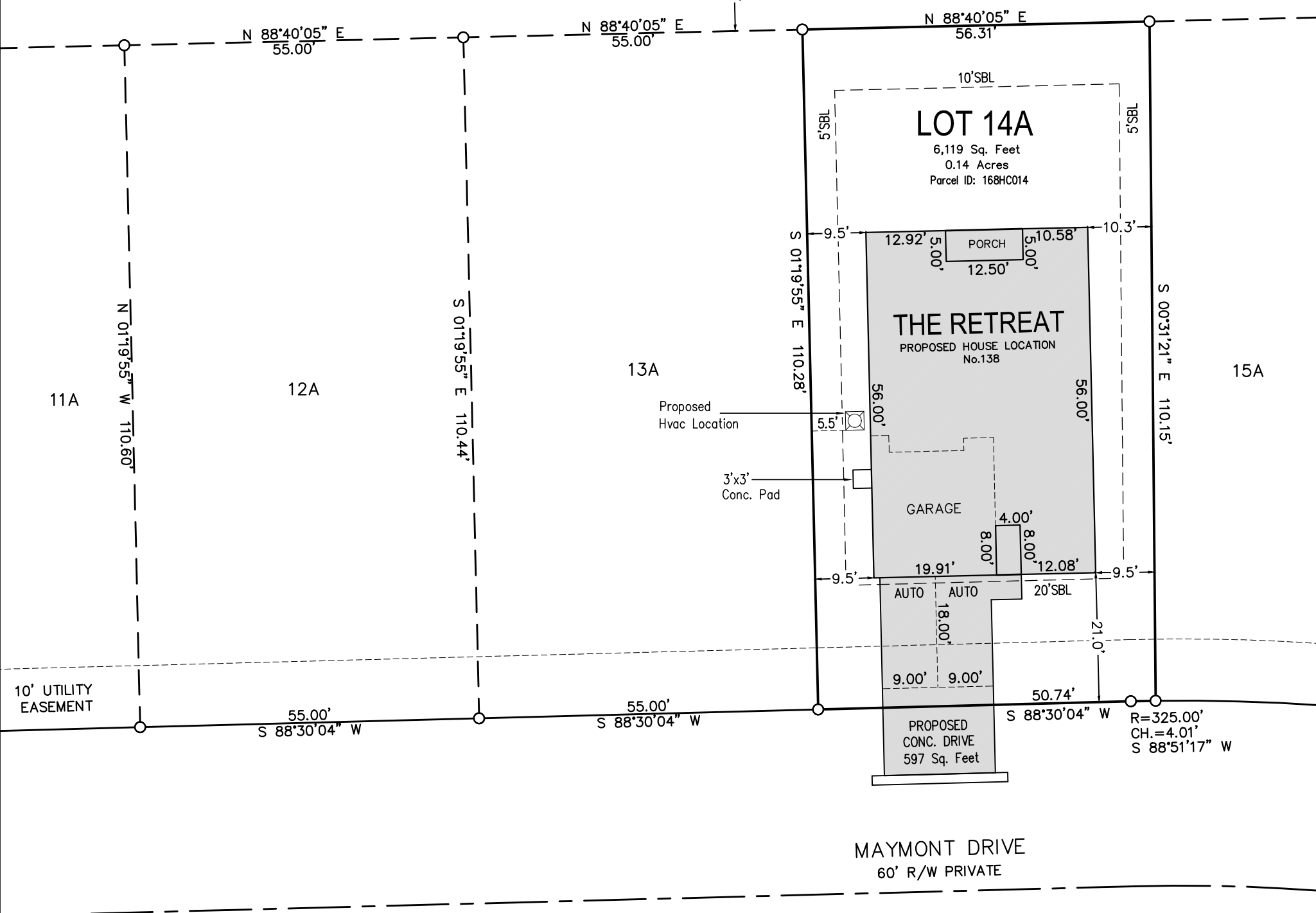


VICINITY MAP

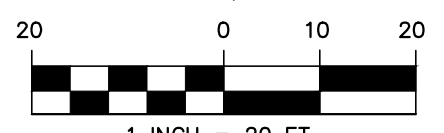
