 Building is a frame residence on pilings with ground level partially enclosed, on a concrete slab. Enclosure is a golf cart garage/storage room. There is an elevator access door in enclosure (visible to the right of the piling in the photo of the interior of the enclosure). Machinery for the elevator is on a higher floor (above 13.6'). The elevator shaft and door enclose approximately 25 sq.ft. with no flood vents. There is an approximately 0.5' lower section of the slab (the slab at 6.4' - Section C2a) under the elevator to allow the floor of the elevator to sit flush with the slab when loading.
 Equipment noted in section C2e is the top of an HVAC compressor platform. Accessible from the platform is an electric meter pan attached to the side of the building above 16.30' and an on demand water heater attached to the building above 12.94'

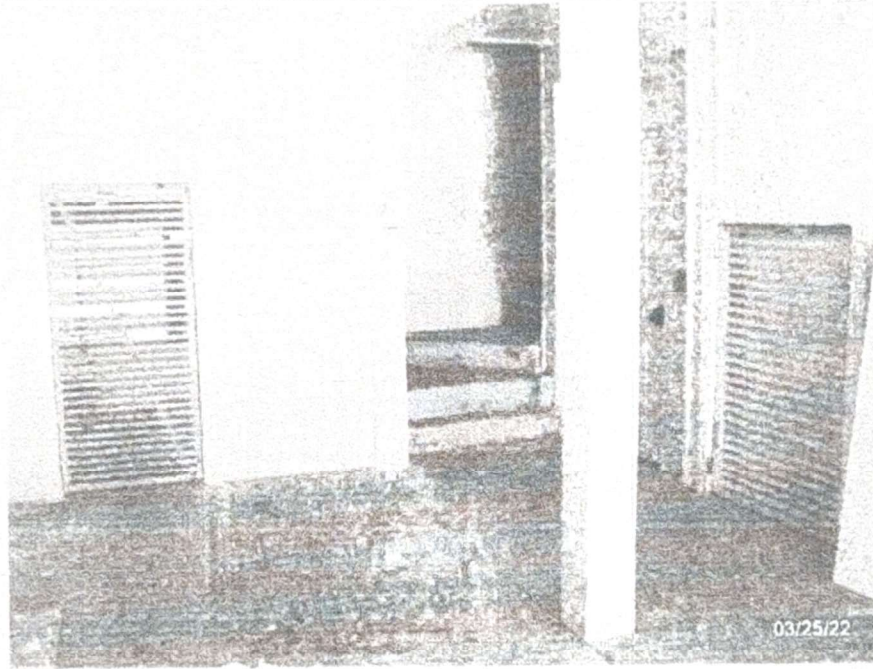

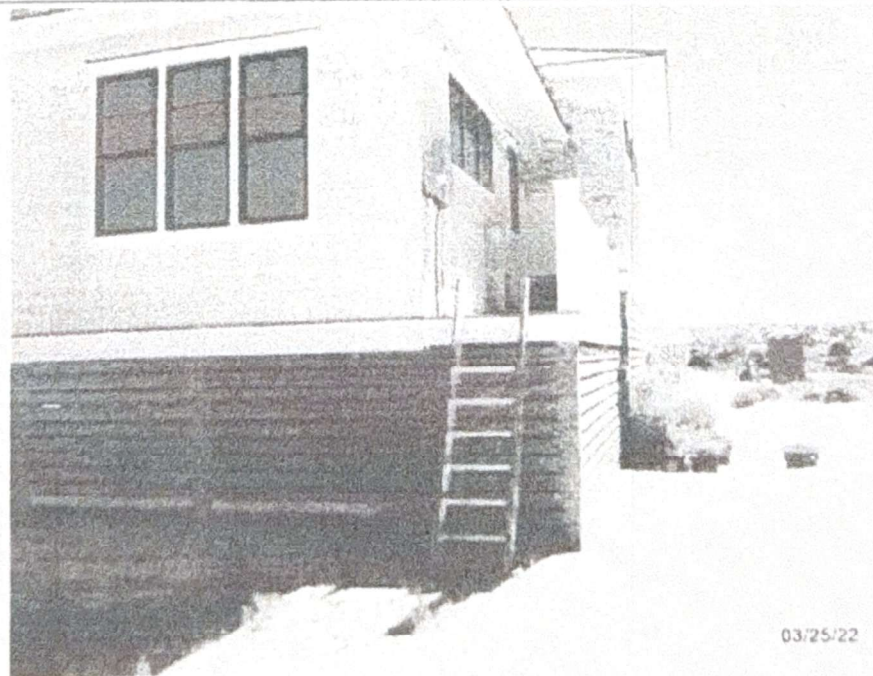
