DEFINITIONS

Resident

Resident: Any Member who is physically residing, as determined by Club Management, in either Duplin, Sampson, Pender, New Hanover or Onslow County.

Non-Resident: Anyone not a resident as above defined.

Guest

Club Guest: Guest not sponsored by member, tee time made at discretion of Golf Staff.

Sponsored Guest: Guest of member but not accompanied by member, tee time must be reserved by member.

Accompanied Guest: Guest of member playing in member's group.

Family Member: Father, Mother, Son, Daughter, Brother, Sister, Grandson, Granddaughter, Son-in-law, Daughter-in-law, Niece, and Nephew playing in member's group and charged to member's account.

Minimums

Food & Beverage: All food & beverage (including alcohol) purchased in the clubhouse and charged to member's club account shall be applied to minimums. All food & beverage charged to members account in conjunction with private catered events shall apply. Club events will apply as designated. Unused minimums may not be carried over from one period to another.

Club: All food & beverage as defined above as well as merchandise, guest fees, cart rentals, locker rentals, Clubhouse Suites and Club Cottage rental shall apply to Club minimum. Lessons, activities, and fitness center services and classes do not apply. Unused minimums may not be carried over from one period to another.
